We established our first supermarket chain "ArdashAzerbaijan" as known as "Araz Supermarkets" in Baku together with Veyseloghlu Holding in 2011. In total, with 21 stores, we created one of the most popular supermarket chains in Azerbaijan within just 3 years. In 2014, we handed over our shares.



After "Rahat Supermarket" project was delivered to us with 4 stores, we increased the store number to 28 within the following 17 months.



Ozbahceci was worked as the CEO of the "Neptun Supermarket". He restructured the foundation of the company and made its growth possible within the following 17 months.





Launched the project from the scratch,
Ozbahceci created a new success story
within 46 days together with 146
employees by opening 46 stores in 46
districts. Currently, the company continues
its activity with high profitability.



Being one of the main idea founders, Ozbahceci has played a critical role in creating and growing the brand value of the "Yerel Zincirler Buluşuyor", which is annually held in Halich Congress and Cultural Center in Istanbul since 2009. Known as the retail event brand in Turkey, "YZC" hosted 7610 professionals from retail sector in 2019.



Ozbahceci worked as the President of Istanbul PERDER and played a critical role in supporting the growth of local retailer chains.

Currently, having 16 supermarket stores, "Bolmart" continues to grow and increase its brand value under Ozbahceci signature. After the 44-day 2nd Karabakh war, Karabakh's first supermarket Bolmart was opened in Shusha.

"Grandmart" supermarket chain keeps growing and increasing its brand value with increased sales and brand awareness from the first day that the company started operating under the Ozbahceci signature. On 09.04.2021, our branch was opened in Aktau / Kazakhstan as the first Azerbaijan supermarket brand.

Founded by Ozbahçeci in 2014, Azcake started as a company, which served bakery products only in the supermarkets. Currently, it is a huge company, which serves bakery products all over Azerbaijan. It is the first business and the first bread factory that started its business activities in Karabakh after the 44-day 2nd Karabakh war.

"Kargofly" offers cargo services at the most affordable prices and with better conditions for Azerbaijani citizens, who shop from Turkish online e-commerce websites.



The "Paper Products Processing" factory, which has been inactive since 2016, was transferred to the balance of "Azerbaijan Industrial Corporation" OJSC in April 2020, and since then the Authority has been actively working to bring the factory back into operation. For this purpose, meetings were held with various investors within the framework of public-private partnerships, and as a result of the negotiations and analyzes, it was decided to organize joint activities with Rafa Group LLC under Ozbahceci's signature. The annual production capacity of diaper equipment in the factory is 218 million units, and the annual production capacity of napkin equipment is 428 million units. For the first time in the history of Azerbaijan, baby diapers produced in Azerbaijan were exported to Uzbekistan and Germany.



The main activity of İmex Trading is the import of food products to the Republic of Azerbaijan and the export of local products of the Republic of Azerbaijan to the world. We exported Azerbaijan products to Qatar supermarkets for the first time.
